

IOWA 600 BOWLING CLUB

2012 MAIL-IN SINGLES TOURNAMENT (USBC Certified)

The Iowa 600 Bowling Club will conduct a mail-in singles tournament for all current members.

There are two forms which must be used, and all information is required. ***The entry form must be returned to the Iowa 600 Bowling Club office postmarked no later than March 1, 2012.*** The score verification form must be postmarked no later than April 10, 2012. Certified league scores for the week of March 4, 2012, through March 10, 2012, will be used. *However, if your scheduled league bowling is postponed that week, scores bowled the week of March 11, 2012, through March 17, 2012, will be accepted.*

Entry fee will be \$5.00 (\$4.30 prize fund; 50¢ expenses; 20¢ secretary fee).

Tournament Rules

1. This tournament will be conducted by the Iowa 600 Bowling Club for its members. The Secretary-Treasurer will be the Tournament Director.
2. An entrant must be a current member of the USBC and the Iowa State USBC WBA. She must also be a PAID member of the Iowa 600 Bowling Club or may join/renew upon entry in this tournament.
3. This tournament will be conducted by submitting USBC women's (or USBC mixed) certified league scores bowled during the week of March 4, 2012, through March 10, 2012. In the event that scheduled league bowling is postponed, scores bowled the following week, March 11, 2012, through March 17, 2012, will be accepted. *Only USBC women's (or USBC mixed) certified league scores will be accepted.*
4. Entrants shall use their highest USBC certified league average, as a regular or substitute bowler, in the following order: (a) book or ending 2010-2011 winter season average, 21 games or more; (b) ending 2011 summer season average, 21 games or more; (c) January 1, 2012, average, 21 games or more; (d) 12 games or more as of the date of her participation in the tournament. Bowlers who do not meet any of the above requirements will be entered with a 240 average. Penalty for submitting an incorrect average is as follows: (a) if the actual average is higher than submitted, the member is disqualified; (b) if the actual average is lower than submitted, prize placing will be based on the average submitted.
5. This tournament will be handicapped at 100% of 240.
6. Rules 319a-2 (10-pin average), 319d (prize winnings provisions), and 319e (tournament average) are waived. Incorrect averages will be governed by Rule 319a-3. All other rules and regulations shall remain in effect. ***DISCLAIMER: USBC language/rules will apply in all areas affected.***
7. Multiple entries may be submitted for each USBC women's (or USBC mixed) certified league in which the participant is bowling. Photocopies of the entry form and of the score verification form will be accepted. Entrant may cash only once.
8. The prize fund will be returned 100% and will be based on a ratio of 1 out of 4 entries.
9. All scores must be bowled in USBC women's (or USBC mixed) certified leagues. Scores bowled in only men's certified leagues or uncertified leagues will not be permitted. An entry will be declared ineligible if the score verification form is returned without the league secretary's signature AND a copy of the league recap sheet.
10. This tournament will carry its own certification. All awards will be issued through leagues.
