There are two forms which must be used, and all information is required. The entry form must be returned to the lowa 600 Bowling Club office postmarked no later than November 22, 2017. The score verification form must be postmarked no later than December 31, 2017. Certified league scores for the week of November 26, 2017, through December 9, 2017, will be used. NOTE: Use your highest score of the two-week time frame. You will have a second chance to better your score – send in the best one! Please call the Tournament Director if encounter any issues for clarification.

Entry fee will be \$5.00 (\$4.30 prize fund; 45¢ expenses; 25¢ secretary fee).

Tournament Rules

- 1. This tournament will be conducted by the Iowa 600 Bowling Club for its members. The Secretary-Treasurer will be the Tournament Director.
- 2. An entrant must be a current member of the USBC and the lowa State USBC WBA. She must also be a PAID member of the lowa 600 Bowling Club or may join/renew upon entry in this tournament.
- 3. This tournament will be conducted by submitting USBC women's (or USBC mixed) certified league scores bowled during the week of November 26, 2017, through December 9, 2017. Use your highest score of the two-week time frame. You will have a second chance to better your score send in the best one! In the event that scheduled league bowling is postponed (or if unable to bowl due to illness, weather, postponements, etc.), please contact the Tournament Director for clarification. Only USBC women's (or USBC mixed) certified league scores will be accepted.
- 4. Entrants shall use their highest USBC certified league average, as a regular or substitute bowler, in the following order: (a) Entrants must use their highest average of not less than 21 games in any league (*including summer*) at the end of the previous season; (b) if a bowler does not have an established average of 21 games or more from the previous season, she shall use her highest average of 21 games or more as of November 19 of the current season; (c) if a bowler does not meet either of the above average requirements, she may bowl with an established average of 12 games or more as of the date of participation (verification from the local association will be required); (d) if a bowler does not meet any of the above average requirements, she may enter the tournament with a 220 average. Penalty for submitting an incorrect average is as follows: (a) if the actual average is higher than submitted, the member is disqualified; (b) if the actual average is lower than submitted, prize placing will be based on the average submitted.
- 5. This tournament will be handicapped at 100% of 220.
- 6. Rule 319a-2 (10-pin average) and Rule 319d (previous prize winnings) are waived. Rule 319e (average adjustment for entry) and Rule 319a-3 (bowlers responsibility for correct average) will apply. All other rules and regulations shall remain in effect. **DISCLAIMER: USBC language/rules will apply in all areas affected.**
- 7. Multiple entries may be submitted for each USBC women's (or USBC mixed) certified league in which the participant is bowling (only one entry per league). Photocopies of the entry form and of the score verification form will be accepted. **Entrant may cash multiple times**.
- 8. The prize fund will be returned 100% and will be based on a ratio of 1 out of 4 entries.
- 9. All scores must be bowled in USBC women's (or USBC mixed) certified leagues. Scores bowled in only men's certified leagues or uncertified leagues will not be permitted. An entry will be declared ineligible if the score verification form is returned without a copy of the league recap sheet (or other verification).
- 10. This tournament will carry its own certification. All awards will be issued through leagues.
