# IOWA WOMEN'S 700 BOWLING CLUB 2010-11 4-GAME SINGLES TOURNAMENT

## RULES

1. Entry will be open to members of the Iowa Women's 700 Bowling Club. Current dues must be paid prior to participating. All entrants must be members of USBC. A non-member may qualify for entry by paying an associate membership fee of \$21.00.
2. This tournament will be USBC certified and USBC rules will govern.
3. The tournament will be a 4-game singles event. The games will be rolled across 8 lanes. Handicap will be 100% of the difference of the entrants' average and 220.
4. Entrants will use highest average of the 2009-10 bowling season, regular or sub of at least 21 games. If no adequate 2009-10 average, entrant will use highest average of at least 12 games in one league in the current (2010-11) season as of September 24, 2010. If none of the above applies, entrant will use highest summer average for at least 21 games in the 2009-10 season. If no average, entrant will be assigned an average of 220. Any average must be from USBC certified leagues. USBC rules 319a-2, 319d, and 319e are waived. The penalty for submitting an incorrect average is as follows: 1. If the actual average is higher than submitted, the member is disqualified. 2. If the actual average is lower than submitted, prize placing will be based on the average submitted. ***Disclaimer: USBC language/rules will apply in all areas affected.***
5. Tournament will be a **WALK-IN format**, but mail-in entries will be accepted. Entries will close Sept. 25, 2010 at 1:00 pm.
6. Entry fee will be \$20.00, lineage \$8.00, prize fund \$11.00, expense 1.00.
7. Tournament management requests bowlers register/check in 30 minutes prior to start of scheduled shift time.
8. In the event of a first place tie, co-winners will be declared.
9. Prize money will be paid one prize for each 3 entries. All prizes will be cash, no trophies will be awarded. Prize fund will be returned 100%.
10. The tournament will be held Saturday, September 25, 2010 at Lightning Lanes in Manchester, IA. Shift time is 1:00 pm. Up to 6 bowlers will be scheduled to a pair of lanes.
11. Automatic scoring will be the official score, bowlers are urged to check their own score at all times.
