# TOURNAMENT RULES

This tournament will be conducted by the Iowa State USBC WBA ("ISUSBCWBA"). The state association manager will be the Tournament Director. This tournament will carry its own certification. Awards will be issued through the 2012 ISUSBCWBA State Championship Tournament.

## QUALIFICATIONS TO BOWL

1. All entrants must be entered in the 2012 ISUSBCWBA State Championship Tournament and meet all eligibility rules of that tournament.
2. USBC rules 319a-e will be waived, except for 319a-3.

## PARTICIPATION

3. Entrants may enter up to twelve times, each time with a different partner from the ISUSBCWBA Board of Directors.

## AVERAGES AND HANDICAP

4. Entrants will use the same average as used in the 2012 ISUSBCWBA State Championship Tournament.
5. Reporting of averages is the sole responsibility of the bowler. Rule 310a, item 3 will be enforced.
6. The tournament director retains the right to verify and correct averages.
7. The tournament will be handicapped at 100% of 240.

## DATES, DEADLINES AND CONDITIONS

8. Entry deadline will be Feb. 1, 2012.
9. Each partner's FIRST TEAM score will be used.
10. The tournament director will be responsible for submitting the scores for both entrants from the team recaps of the ISUSBCWBA State Championship Tournament for this tournament.

## FEES

11. Entry fee will be \$5.00 (\$2.25 prize fund, \$2.25 to the International Bowling Museum and Hall of Fame, 25¢ director's fee, 25¢ expenses).
12. Entry fees are not transferable or refundable.

## PRIZES

13. Prize money will be returned 100% and will be paid on a ratio of 1 for each 5 entries or major fraction.

## DISCLAIMER/PROTEST

14. All other USBC rules and regulations shall apply. USBC language/rules will apply in all areas affected.
15. The ISUSBCWBA Board of Directors shall decide any questions not covered by these rules and shall have the power to hear and act on all protests concerning the tournament and its rules.

NOTE: Selected Board Member pays no entry fee and is not eligible for any prize winnings.
