TOURNAMENT RULES

This tournament will be conducted by the Iowa State USBC WBA. The Association Manager will be the Tournament Director. This tournament will carry its own certification. Awards will be issued through the Iowa State USBC WBA Championship Tournament.

QUALIFICATIONS TO BOWL

1. All entrants must be entered in the Iowa State USBC WBA Championship Tournament and meet all eligibility rules of that tournament.
2. USBC rules 319a-e will be waived, except for 319a-3.

PARTICIPATION

3. Entrants may enter multiple times, each time with a different partner from the Board of Directors.

AVERAGES AND HANDICAP

4. Entrants will use the same average as used in the Iowa State USBC WBA Championship Tournament.
5. Reporting of averages is the sole responsibility of the bowler.
6. The Tournament Director retains the right to verify and correct averages.
7. The tournament will be handicapped at 100% of 220.

DATES, DEADLINES AND CONDITIONS

8. Entry deadline will be the day of participation in the first team event bowled per entrant.
9. Each partner's FIRST TEAM score will be used. In the event the Board member does not bowl in the team event, her doubles scores will be used. In the case of a substitution in the team event, the substitute's score will be used. In the event that a Board member is unable to bowl in the team or doubles event the substitute's score will be used.
10. The Tournament Director will be responsible for submitting the scores for both entrants from the team recaps of the Iowa State USBC WBA Championship Tournament for this tournament.

FEES

11. Entry fee will be \$5.00 (\$2.00 prize fund, \$2.00 to the International Bowling Museum and Hall of Fame, 50¢ director's fee, 50¢ expenses).
12. Entry fees are not transferable or refundable.

PRIZES

13. Prize money will be returned 100% and will be paid on a ratio of 1 for each 5 entries or major fraction.
14. No entry fees will be refunded after fifteen (15) days from the closing date or fifteen (15) days from the date of confirmation. Rescheduling of any event may be made at the discretion of the Tournament Director. Refunds for overpayment of fees will not be issued for less than \$5.00.

DISCLAIMER/PROTEST

15. All other USBC rules and regulations shall apply. USBC language/rules will apply in all areas affected.
16. The Board of Directors shall decide any questions not covered by these rules and shall have the power to hear and act on all protests concerning the tournament and its rules.

NOTE: Selected Board member pays no entry fee and is not eligible for any prize winnings
